If you take part in this campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these campaign rules.

<b>Is there a limit on the number of times you can qualify for the offer?</b>	N/A. Members can book as much as they want and travel until 31 August 2021.
<b>Data Usage and Privacy Policy</b>	Participants in the campaign understand and agree that, in order to offer the campaign, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image. #### IMPORTANT

- While the promoter(s) may allow you extra time to comply with your obligations or decide not to exercise some or all of our rights, or waive certain requirements, the promoter(s) can still insist on the strict application of any or all of its rights at a later stage. You must not assume that this means that the rules have been changed or that it no longer applies to you.
