In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

<b>Eligibility:</b>	This competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme.

<b>Products to which the Competition is Applicable:</b>	This Competition is valid on any Apple product on the eBucks Shop.
<b>Is there a limit on the number of times you can enter the Competition?</b>	There is no limit to the number of times one can enter the Competition. Each transaction will count as a separate entry.
<b>How will the winner be chosen?</b>	By random draw from all eligible entries received before the closing date and time. The draw will take place by Friday, 24 April 2020 at eBucks' offices.
