| <p>Is there a limit on the number of times a customer can redeem/enter?</p> | <p>There is no limit to the number of entries per customer. Each qualifying purchase/transaction of R350.00 or more will count as a separate entry, and the minimum amount is not cumulative (for example, one R700.00 purchase will count as one entry, not two separate entries).</p> |

| <p>How will winner(s) be chosen?</p> | <p>A draw will take place by 13 May 2022 to determine the winners. The winners will be drawn from the transactional sales data for the Competition period by Clicks.</p> <p>Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the eBucks and Clicks websites.
