<b>Promoter(s) Name(s):</b>	This Campaign is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks"), an Authorised Financial services and Registered Credit provider having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Clicks. The person responsible for conducting the promotional Campaign on behalf of eBucks is Mahlatshe Makwela, a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

The 15% discount is in addition to earning up to 15% back in eBucks when shopping at Clicks.</p> <p>The customer will save the advertised additional 15% at the till in-stores or at checkout online when purchasing made 4 baby products (excludes all legislated products).</p>
<b>How to participate?</b>	<p>To qualify for this exclusive benefit, customers must register their Clicks Clubcard on the FNB/RMB Private Banking App.</p> <p>Follow these steps on the FNB/RMB Private Banking App to register your Clicks Clubcard:</p> <ol style="list-style-type: none"><li>1. Visit the eBucks tab on the FNB/RMB Private Banking App</li><li>2. Click on Partners</li><li>3. Click on the Clicks icon</li><li>4. Register and fill in the form</li><li>5. Your registration will be completed</li></ol> <ul style="list-style-type: none"><li>• In addition, the customer must have registered for Clicks promotions on the FNB app.</li><li>• The customer must use their Clicks ClubCard during the transaction and pay with their FNB/RMB Private Bank card.</li><li>• The made 4 baby offer is valid for one transaction per customer, between 21 January and 19 May 2021.</li></ul>
<b>Campaign starts on:</b>	Campaign starts on 21 January 2021 at 00:00:01am.
<b>Campaign ends on:</b>	Campaign ends on 19 May 2021 at 11:59:59 pm. The promoter(s) reserve the right to extend the Campaign by amending these Campaign rules.
<b>Is there a limit on the number of times a customer can redeem?</b>	There is a limit of one redemption (transaction) per customer. The customer will save the advertised extra 15% at the till in-stores or at checkout online when purchasing made 4 baby products. Promotion applies

	to selected products only (excludes all legislated products such as Milk formulas, feeding products/items and teats).
<b>Eligibility: Who qualifies to take part?</b>	This Campaign is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, have an FNB/RMB Private Bank transactional account and is a member of the eBucks Rewards Programme. excluding the categories of people listed below who cannot take part.
<b>Data Usage and Privacy Policy</b>	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants' first name, last name, email address, mobile number and in certain instances your image. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.
<b>General</b>	<p>No correspondence will be entered into regarding either this Campaign or these rules. In the unlikely event of a dispute, eBucks' decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Campaign in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. The laws of the Republic of South Africa govern this Campaign. If any provision or part of these rules is deemed void or otherwise unenforceable in law, then that provision or part shall be deemed excluded and the remainder of these rules shall remain in force. **IMPORTANT**

- You agree to indemnify the promoters fully for any loss or damage the promoters may suffer because you breached the Campaign rules.
