Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Mr Delivery (Pty) Ltd ("Mr D Food"). In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
The Discount:	<ul style="list-style-type: none"> • This campaign offers FNB/RMB Private Banking customers R60 off their First Mr D Food order as first-time shoppers when they spend R100 or more in South Africa during the campaign period. • In order to qualify for the discount, apply the coupon code "FIRST60", to their first order placed on the Mr D Food mobile application; • Use your qualifying FNB/RMB Private Bank card or eBucks to make payment; • The coupon code has no cash value and cannot be combined with any other discounts, coupon codes or promotions; • Successful redemption of the coupon code is subject to the availability and acceptance of the order, by the Mr D Food Restaurant partner the qualifying order was placed with; • Access to and use of the Mr D Food App will be subject to Mr D Foods Terms and Conditions and Privacy Statement applicable to all customers who use the platform.

Eligibility: Who qualifies to take part?	This Campaign is open to anyone who has an FNB/RMB Private Bank account holders and has downloaded both the FNB and Mr D Food App, is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
How to participate?	<ul style="list-style-type: none"> • Download the Mr D Food App and register • Order on the Mr D Food App and insert the coupon code "FIRST60" at check out • receive R60 off your first-time purchase to the value of R100 or more • Choose card payment method, use your FNB/RMB Private Banking to make payment • Complete your order <p>The coupon code will only be applicable for a customer's first order on the Mr D Food app and needs to be entered separately for each order placed.</p>
Products to which the Discount is Applicable ("discounted item"):	This offer is valid on a customer's first Mr D Food order of at least R100 made through the Mr D Food App, including delivery cost and any service cost which might be charged by Mr D Food.
Is there a limit on the number of times you can use the discount voucher?	The offer is limited to the first order on the users Mr D Food profile, of at least R100.
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants', first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Campaign, may, subject to prevailing

General	No correspondence will be entered into regarding either this Campaign or these rules. In the unlikely event of a dispute, eBucks' decision shall be final. eBucks reserves the right to amend, modify, cancel or withdraw any aspect of this Campaign in its sole discretion at any time without notice or liability. eBucks cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Campaign agree that eBucks will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a code, or from participation in this Campaign. IMPORTANT
