An Authorised Financial service and Registered Credit provider. Having its principal place of business at 7 Merchant Place, Fredman Drive, Sandton, Johannesburg, Gauteng, South Africa in collaboration with Superbalist. In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
