Participants must pay using their FNB/RMB Private Bank (Cheque or Credit) card or eBucks or a combination of both. Only products purchased on eBucks Shop will be eligible for entry to the competition.
Products to which the Competition is Applicable:	This Competition is valid on any Cable Guy products on the eBucks Shop
Is there a limit on the number of times you can enter the Competition?	There is no limit to the number of times one can enter the Competition. Each transaction will count as a separate entry.
How will the winner be chosen?	By random draw from all eligible entries received before the closing date and time. The draw will take place by Friday, 28 May 2021 by eBucks.
