## **COMPETITION RULES**

Read these Competition rules carefully. These Competition rules ("rules") explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

Promoter(s) Name(s):	This Competition is run by FNB-eBucks Rewards, a business unit within FirstRand Bank ("FNB") Limited (Registration Number. 1929/001225/06) ("eBucks") having its principal place of business at 10th Floor, FNB Place, Bank City, Cnr Kerk and Diagonal Street, Johannesburg Gauteng, South Africa, 2000. The person responsible for conducting the promotional Competition on behalf of eBucks is Dimakatso Mataruka, a Merchandise Planner. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants and winners as "you".
The prizes	<ul> <li>The Competition runs for 4 weeks with one winner that will be announced at the end of the Competition period.</li> <li>The winner will receive eB1 000 000 (one million eBucks) (with an equivalent Rand value of R100 000 (one hundred thousand Rand)).</li> <li>The prize will be deposited into the prize winner's eBucks account.</li> <li>The prize is not redeemable for cash and is not transferable to any person other than the drawn winner.</li> <li>Participants must have a minimum spend of R2500 (two thousand five hundred Rand), eB25 000 (twenty-five thousand eBucks) or a combination spend of Rand and eBucks that adds up to R2500 or eB25 000.</li> <li>Each individual order (regardless of the number of items in the order or the maximum value of the order) counts as one entry.</li> </ul>
Entries open:	Entries open on 1 March 2018 at 8:00am
Entries close:	Entries close on 31 March 2018 at 11:59:59 pm. All entries must be received by us before 11:59:59 pm on 31 March 2018. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
Is there a limit on the number of times you can enter?	There is no limit on the number of entries. Every separate purchase of one or more products from the "Apple" category on the eBucks Shop to the value of at least eB25 000 (R2 500) will count as one entry into the draw.
Winner announced on:	The winner will be announced on 12 April 2018.
Eligibility: Who qualifies to take part?	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme, excluding the categories of people listed below who cannot take part. By entering this Competition, participants warrant that they do not fall into any of the below mentioned excluded categories of people.

How to enter?	There are no entry fees. To enter, Participants must (between 1 March 2018 and 31 March 2018), purchase one or more products from the "Apple " category in the eBucks Shop to the value of at least eB25 000 or R2 500. If however you return the product(s) purchased before the draw date, your entry will be invalid and will be withdrawn from the Competition. By purchasing the product(s) as described above you will automatically be entered into the Competition. eBucks is not responsible for any lost, corrupted or delayed entries and these will be deemed invalid. Entries must be received by eBucks after the Competition opening time and no later than the Competition closing time. Each entry constitutes full and unconditional acceptance of these Rules. eBucks reserves the right to disqualify anyone in breach of these Rules. No telephonic, faxed, emailed or posted entries will be accepted.
How will winner(s) be chosen?	A random draw will take place on 5 April 2018 to determine the winner. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the eBucks Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. How will winner(s) names be announced?	The winner will be notified within 48 hours of the draw taking place via email by the eBucks Corporate Communications team, to the contact details recorded on the winner's eBucks account. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot

	guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these Rules shall remain in force. Any violation of these Rules will result in the immediate disqualification of the transgressing participant from the Competition.

#### IMPORTANT

- You agree to indemnify the promoters fully for any loss or damage the promoters may suffer because you
