<b>Promoter(s) Name(s):</b>	This Competitionis run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 ("eBucks")), an Authorised Financial services and Registered Credit provider having its principal place of business at 7 Merchant Place, 1 <sup>st</sup> Floor, 9 Fredman Drive, Sandton, Gauteng, South Africa, 2000, in collaboration with Intercape. The person responsible for conducting the promotional Competitionon behalf of eBucks is Adrian Peters a Partner Growth Manager at FNB-eBucks. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".
<b>The competition:</b>	The purpose of the Competition is to offer customers a chance to win Intercape vouchers when they spend at Intercape.
<b>How to participate/enter?</b>	Buy a bus ticket instore or online at <a href="https://www.intercape.co.za/">https://www.intercape.co.za/</a> and automatically be entered into a draw to win one of 5 return bus tickets to any destination in South Africa. Payment must be made using your FNB/RMB Private Banking card and/or eBucks.
<b>The prizes</b>	5 x return bus tickets to any destination in South Africa.
<b>Competition starts on:</b>	Competitionstarts on 17 November 2021 at 00:00:01am
<b>Competition ends on:</b>	Competitionends on 24 December 2021 at 11:59:59 pm. The promoter(s) reserve the right to extend the Competitionby amending these rules.
<b>Is there a limit on the number of times a customer can redeem/ enter?</b>	There is no limit to the number of entries per customer. Every separate qualifying purchase made at the till in-stores or at checkout online at <a href="https://www.intercape.co.za/">https://www.intercape.co.za/</a> using your FNB/RMB Private Banking or eBucks does qualify a customer.
<b>Eligibility: Who qualifies to take part?</b>	This Competitionis open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry, has an FNB/RMB Private Bank transactional account and is a member of the eBucks Rewards Programme.

<b>How will winner(s) be chosen?</b>	<p>A draw will take place during the week of 7 January 2022 to determine the winners. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk &amp; Compliance team at the Intercape office. The winners will be drawn from the transactional sales data for the Competition period.</p> <p>Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the eBucks and Intercape websites. The random entries drawn will be checked to establish whether they meet the Competition qualifying criteria and if so that entry will be the prize winners, subject to eBucks being able to contact such winners within 72 (seventy two) hours of the draw taking place.
