Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.

<b>Eligibility:</b>	FNB Premier, FNB Private Clients, FNB Private Wealth RMB Private Bank account holders.
<b>Who qualifies to take part?</b>	This Campaign is open to anyone who is an FNB account holder, who is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
<b>How to participate?</b>	Book your Avis Car Rental booking on the App or on the eBucks Travel website.
<b>Products to which the Discount is Applicable (“discounted item”):</b>	This offer is valid at participating Engen garages in-store.
<b>Is there a limit on the number of times you can use the discount voucher?</b>	You can book as many car rental bookings as you wish during the campaign period and each booking qualifies you for a voucher and can only be used once-off.
<b>Data Usage and Privacy Policy</b>	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. #### IMPORTANT

- **You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the Campaign rules.
