Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. If you take part in this Campaign and/or accept any discount, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Campaign rules.

An Authorised Financial service and Registered Credit provider. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.

Products to which the Discount is Applicable (“discounted item”):	Vouchers can be redeemed at all Wimpy restaurants.
Is there a limit on the number of times you can use the discount voucher?	You can make as many domestic flight bookings as you wish during 1 – 30 November. 1 voucher per booking will be allocated.

IMPORTANT
