Read these Campaign rules carefully. These Campaign rules explain your rights and duties in connection with this Campaign. An Authorised Financial service and Registered Credit provider. Having its principal place of business at 6 Merchant Place, 2nd Floor, Fredman Drive, Sandton, Johannesburg, Gauteng, South Africa, 2000, in collaboration with Wimpy. In these rules, we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.

<b>Eligibility:</b>	FNB Gold, FNB Platinum, FNB Private & Healthcare and FNB Enterprise account holders.
<b>Who qualifies to take part?</b>	This Campaign is open to anyone who is an FNB business account holder, who is a legal resident of the Republic of South Africa and is a natural person 18 years of age or older at the time of redemption.
<b>How to participate?</b>	<p>Book on the banking App or eBucks Travel online.</p> <p>Should there be online failures and a booking is made via the eBucks Travel desk, that will qualify.</p>
<b>Products to which the Discount is Applicable (“discounted item”):</b>	All domestic and international airlines departing from South Africa.
<b>Is there a limit on the number of times you can Earn back?</b>	The offer is limited to flight bookings only. You can book as many times as you want, there is a Rand Cap limit per customer as stated under “The offer”
<b>Data Usage and Privacy Policy</b>	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants. This personal information may include participants’, first name, last name, email address, mobile number and in certain instances your image. eBucks will treat your information in total confidence and will not sell, share or rent this information to any other third parties. eBucks may disclose information if required to do so by law or if it is required to protect the safety, rights or property of the eBucks, our members, customers or the public.

**IMPORTANT**
