In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

Is there a limit on the number of times you can Earn back?	The offer is limited to flight bookings only. You can book as many times as you want, there is a Rand Cap limit per customer as stated under "The offer"
