In these rules, we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants as "you".

How to participate?	Book a bus ticket with Quickbus on the FNB App
Products to which the Discount is Applicable ("discounted item"):	This offer is valid on Mr D Food orders with a mininmu spend of R120, excluding deliveries.  The offer cannot be used for grocery, convenience and liquor store orders.
Is there a limit on the number of times you can use the discount voucher?	You can make as many bus bookings as you wish, each booking will qualify for a R100 (one hundred rands) Mr D voucher.
Data Usage and Privacy Policy	Participants in the Campaign understand and agree that, in order to offer the Campaign, eBucks may collect and use personal information about participants.
