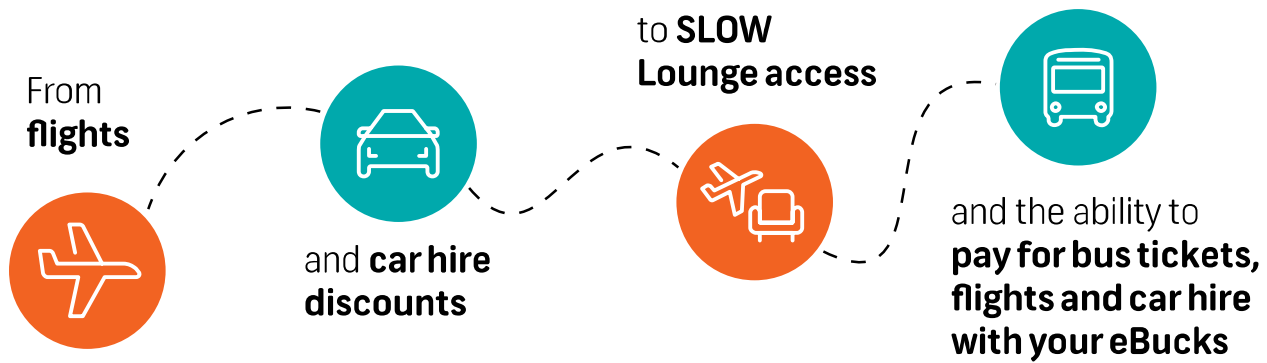

1. Qualifying for travel rewards

To earn eBucks Travel rewards, a business requires an active qualifying FNB current account and must be registered for eBucks.

Your **travel rewards** are based on the **highest FNB Business current account type** that you hold.

For example: if you hold an **FNB Platinum Business Current Account**



and an **FNB Enterprise Business Credit Card**



your reward level and eBucks Travel discount will be based on the **FNB Platinum Business Current Account** reward level as this is the higher qualifying product.

Receive up to **40%* off** on selected domestic and international flights and domestic car hire when booking with eBucks Travel on the FNB App or the eBucks Travel website. Discounts are deducted from your [Annual Discount Savings](#) amount, which is available for use between 1 July and 30 June annually, after which it will reset.

**Discounts exclude taxes, VAT and surcharges. Discounts are based on your reward level. The higher your reward level, the higher your discount.*

View the 'Track my rewards' tab on the FNB App or ebucks.com every month to track your progress towards moving up reward levels.

b. Pay with eBucks

3. Annual Discount Savings

Your Annual Discount Savings is the **total rand value of the flight and car hire discounts** you can redeem for your business with eBucks Travel every year. As you book discounted flights and car hire, the discount rand value will get deducted from your available Annual Discount Savings balance.

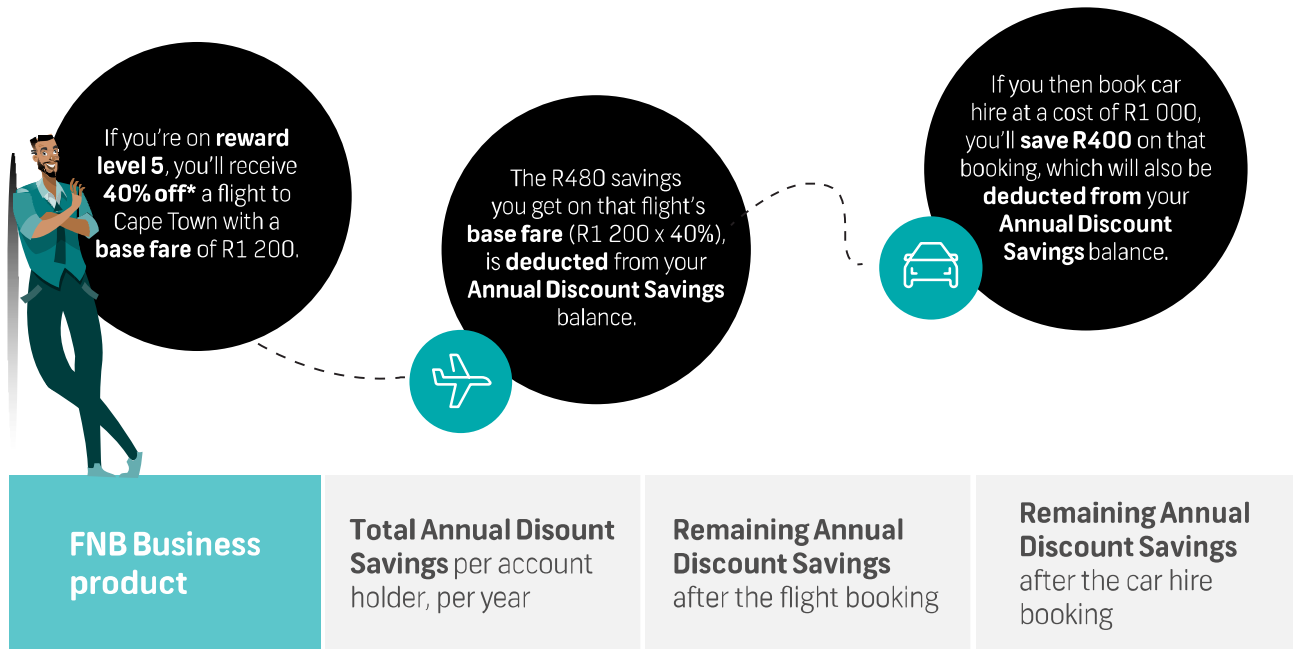
This Annual Discount Savings amount is determined by the highest type of Business account you have with FNB and is allocated to your business to use from 1 July to 30 June each year.

Your Annual Discount Savings means that you do not have a pre-defined limit on the number of discounted travel bookings you can make in a 12-month period.
